### **Absentee Voting Begins October 8, 2018 for the General Election in the Dallas County Auditor's Office.**

**Adel, Iowa** - Dallas County Auditor and Commissioner of Elections Julia Helm has announced that absentee ballots for the November 6, 2018 General Election will be available to be voted in the Dallas County Auditor's Office beginning on October 8, 2018.

Absentee ballots must be requested in writing. Forms are available at the Auditor's Office and on the Iowa Secretary of State's website at [www.sos.iowa.gov](http://www.sos.iowa.gov). Ballots returned through the mail must be postmarked by midnight, November 5, 2018. The Auditor encourages those returning their ballots via the postal service to mail them before November 1, 2018.

**All requests for ballots** to be mailed must be received by the Auditor's Office by 5 p.m. October 27, 2018.
